


The OAP Web Site

For my educational article for this issue of <u>The Oregon Agenda</u>, I was asked to write about how one can find the Oregon Association of Parliamentarians (OAP) web site on the National Association of Parliamentarians (NAP) web site. The first step is to type the URL for the NAP web site, <u>http://parliamentarians.org/</u>, into your web browser. This will bring you to the NAP home page, which you can see in Figure 1.

Take note of the navigation links on the left. You will use these to navigate to the OAP web site. From the NAP home page, click the "NAP Organization" link. I've highlighted this link with a red outline. When you click this link, it will take you to the "NAP Organizational Structure" page, which you can see in Figure 2.

Once you arrive on the "NAP Organizational Structure" page, the navigation links on the left will expand to include links to pages related to the national organization, districts, associations, units, youth groups, and clubs. From this page, click on the "Associations" link, again highlighted with a red outline. When you click this link, it will take you to a web page listing all of NAP's associations. You can see a subset of the list of associations in Figure 3.




Figure 4: OAP Home Page

From the list of NAP associations, click on "Oregon", and you will be taken to the home page of the OAP web site, which you can see in Figure 4. The OAP home page briefly describes OAP, outlines how one can join OAP, and has a link to download the OAP bylaws. There are links on the left to the various pages of the OAP web site. "News and Events" highlights upcoming events in Oregon and has links to download recent issues of <u>The Oregon Agenda</u>. "Meetings" mentions the various meetings of OAP. "Units" includes information from OAP's units, including when and where they meet. "Contact Us" provides contact information for all OAP officers and committee chairmen.
