EXERCISE YOUR RIGHTS

Robert's Rules of Order grants rights to various groups of members in an assembly. Most everyone is aware of the right of the majority. After all, voting on motions is the typical way of handling business, and nearly every motion requires at least a majority vote to be adopted. However, even individual members have rights in an assembly. Among these rights is the ability to bring up issues and demand a resolution using one of the following motions: Call for the Orders of the Day, Raise a Question of Privilege, and Point of Order.

The motion to Call for the Orders of the Day is a request that the assembly take up whatever business is currently scheduled in the program. As long as the chair follows the program, this motion is not needed. However, if the chair deviates from the program this motion can be used to bring things back on track. This is important for meetings with tight schedules to ensure that critical business is dealt with in time. Note that making this motion does not guarantee that the program will be followed, since two-thirds of the members could vote to do otherwise.

One use of the motion to Raise a Question of Privilege is to address issues affecting the assembly. Examples

of such issues include an uncomfortable temperature or a problem affecting your ability to hear the proceedings. If there is an issue interfering with your participation in a meeting, you can make this motion to demand that the issue be resolved.

The motion to make a Point of Order is used to call for enforcement of the rules. This motion can be used to enforce simple rules, such as the rules of debate, or even to enforce the bylaws of the society. A Point of Order typically needs to be made at the time a breach occurs. The exception to this rule is for breaches that are of a continuing nature, in which case a Point of Order can be made at any time during the continuance of the breach. Note that making this motion does not guarantee that the rules will be enforced, since the chair's ruling on a Point of Order can be overturned by a majority of the members.

As you can see, Robert's Rules of Order grants rights to individual members in an assembly. These rights include the ability to demand that issues be resolved by using the motions described above. If you have an issue that needs to be resolved, don't hesitate to exercise your rights!
