Tina Penman, RP, gave us information about using Google Docs and Google Hangouts, even though she was in Ohio. Larry Taylor, RP, demonstrated how to use Zoom, an on-line meeting application. I use Zoom for many of my meetings and it is a great, fairly-easy-to-use tool for both the participants and the host. Jeff Weston, who is an important part of continuing education at NAP, explained the program used by the education committees to do much of the distance training, Adobe Connect. Finally, Beverly Przybylski, PRP, presented a workshop called "Electronic Meeting Minutia." This included information about special

OAP BYLAWS AMENDMENTS BY PATRICIA GETCHELL, PRP-R, BYLAWS/PROCEDURE MANUAL COMMITTEE CHAIR

The following proposed bylaw amendment was presented by the committee at the March 2019 OAP Annual Meeting and was adopted. The words "on the 3rd Friday/and or Saturday" were struck from Article VII: Meetings, Section 1.

The current bylaw now reads: "An annual meeting shall be held in March, at a place determined by the Board of Directors, for the purpose of electing officers and electing a nominating committee in even-numbered years, electing delegates and alternates to NAP conventions in odd-numbered years, receiving written reports of officers, chairmen of standing and special committees and unit presidents of their year's activities, and transacting such other business as properly comes before it."

Additionally, an emergency bylaw amendment was accepted and adopted based on a recommendation from the investment firm, Raymond James. A new section was added to the duties of the treasurer. Article V: Officers, Section 6. Duties of Officers, Subsection D.2. "Be authorized to open and close accounts, and transfer assets between accounts, as directed by the Board of Directors or the Association."

The updated bylaws were forwarded to Larry Taylor for inclusion on the OAP website and President Alice Bartelt to copy all OAP members. The current OAP bylaws may be found on the OAP website at https://www.oregonap.org/.

POSTPONE TO A CERTAIN TIME BY ELAINE CARLSON, OAP VICE-PRESIDENT

I recently prepared a unit lesson on Order of Business and the motion *Postpone to a Certain Time*, partly to clarify in my own mind the correct way to postpone business and how it is handled in the agenda or order of business of the next meeting. This article hits on the high points and mentions several important rules to remember.

The subsidiary motion, **Postpone to a Certain Time**, is useful when an assembly prefers to consider the pending main motion later in the same meeting or at

another meeting. This motion takes precedence over the main motion, the subsidiary motions to *Postpone Indefinitely*, to *Amend*, and *Commit*. Its characteristics: it is out of order when another has the floor, must be seconded, is debatable, is amendable as to the time to which the main motion is postponed, requires a majority vote in its simple form, and an affirmative vote on the motion can be reconsidered.

Assemblies meeting less than at quarterly time intervals,

can postpone the main motion to the next meeting. If the assembly meets less often, the question cannot be postponed beyond the present session, and it may be necessary to provide for an adjourned meeting to handle the motion.

Another important rule to remember is that **Postpone** A matter of pressing importance can also be made to a Certain Time can only be applied to the immediately pending main motion. This is one important characteristic of subsidiary motions. It is not in order to postpone a class of business composed of several items such as reports of officers or committees. Each report can be postponed individually as it is called for. The assembly rules interfering with it shall be suspended for its can vote to suspend the rules and take up items out of the scheduled order of business if they wish. Suspend to be handled before any other matter at the next the rules always requires a two-thirds vote.

Remember also that any matter that the bylaws specify be handled at certain session, such as election of officers Another point to remember is that a special order or delegates, cannot be postponed to another meeting. This is another situation where the assembly may set an adjourned meeting if necessary.

As mentioned above, majority vote is required simply to postpone the motion to the next meeting. This item of business comes up under General Orders when this category is reached in the order of business. If two or more motions were postponed, each is taken up in the order in which it was made at the previous meeting.

If members desire to make the postponed motion a Special Order, the member should state in the motion that the item of business be made a special order for that meeting. This requires a two-thirds vote. The

motion can specify a certain hour when it is to be considered. A special order for a particular hour cannot be considered before that hour except by a two-thirds vote. In the Order of Business, Special Orders are considered after Reports of Officers, Boards, and Standing Committees.

the special order for the meeting. The special order for the meeting will come up as soon as the minutes have been approved, and nothing else will be considered until it has been disposed of. A two-thirds vote is required since the specified time stipulates that any consideration. If there is business that members want meeting, postponing and making the motion a Special Order is the step to take.

does not interfere with a recess or adjournment that is scheduled for a particular hour. When that hour arrives, the chair announces it, and declares the assembly in recess or adjourned, even if a special order is pending that was made before the hour of recess or adjournment was fixed.

Most of us have postponed an item of business to the next meeting, but we can use Postpone to a Certain Time to not only postpone but also to make it a Special Order for priority handling.
