PARLIAMENTARY LAW & THE DISTRIBUTION OF POWER BY LAWRENCE TAYLOR, PRP, OAP VICE-PRESIDENT

Within the 396 words of the 12th amendment of the U.S. Constitution is the following language regarding the counting of Electoral College votes:

The President of the Senate shall, in the presence of the Senate and House of Representatives, open all the certificates and the votes shall then be counted;

The President of the Senate is defined in Article I, Section 3 of the U.S. Constitution, which states:

The Vice President of the United States shall be President of the Senate...

Recently, parliamentarians were mentioned in the national news. It was reported that the U.S. Vice President had consulted several parliamentarians to get their opinion on what powers are given to the Vice President in the 12th amendment. He did this because the President had stated, *"The Vice President has the power to reject fraudulently chosen electors."*

He further stated that the Vice President *"has the option to decertify the results from disputed states or reject"* illegal and corrupt results. This process is further defined in the U.S. Code, Title 3, Chapter 1, § 15 - Counting electoral votes in Congress.

Robert's Rules of Order Newly Revised (12th ed) in the chapter entitled "Principles Underlying Parliamentary Law," states the following:

Parliamentary procedure enables the overall

membership of an organization—expressing its general will through the assembly of its members both to establish and empower an effective leadership as it wishes, and at the same time to retain exactly the degree of direct control over its affairs that it chooses to reserve to itself.

This means that "control" (or more clearly expressed as "power") is either reserved for the organization or allocated through the rules adopted by the organization. These governing rules are in the form of a constitution or bylaws, and if power isn't "allocated," it is reserved by the membership.

This disagreement between the President and the Vice President arises from not distinguishing the difference between deliberative assemblies (which are governed by parliamentary law) and entities like businesses, where power originates with the owner or the board of directors. The President appears to have assumed that because the Vice President is the presiding officer during the counting of Electoral College Votes, he has the power to make decisions, as a CEO would in a business.

This misunderstanding of how power is allocated in deliberative assemblies is not uncommon. It is not unusual to find the elected leadership exercising more power than has been allocated to them. Because members often do not understand parliamentary law, they are unaware when their powers are being appropriated.

OAP HISTORY BY TERESA STONE PRP CP-T, OAP HISTORIAN

THE 60's

In the 1950s, Oregon's parliamentary units directly affiliated with the National Association of Parliamentarians (NAP). They met informally in the state in the decade of the 1950s, but these units became more serious in their pursuit of a statewide association as the 1960s decade progressed. Fast-forward to 1968 and as quoted directly from the OAP History:

For a number of years there had been some interest in organizing a state association. As the number of units grew and the state membership increased, the interest grew even stronger. With this in mind, the first organizing meeting was called for August 23, 1968, in the Ross Hollywood Funeral Home at 48th and

Sandy Blvd. After much discussion, a second meeting was held November 1, 1968, at the same place, and the third meeting November 22, 1968, at which temporary officers were elected.

In September there was a new NAP Seventh District Director, Josephine Kolb of Seattle. Josephine and the NAP First Vice-President, Blanch Wilkinson, of Tacoma, came to Portland to assist with the proper procedures in organizing. At the third organizing meeting on November 22nd, temporary officers were elected with Rita Robedeau, President; Bonnie Sloan, Vice-President; and Bertha Hall O'Shea, Secretary.

Barbara Pennington, of the Lewelling Unit, presented the first OSAP Bylaws, which were approved. The designated name, "the Oregon State Association of Parliamentarians." There were five units joining the state association: Barlow, Lewelling, Oregon City, Salem, and Spencer Butte, for a state membership of fifty-two members.

By signing the roll on December 1, 1968, the following individuals became charter members of the OSAP: Barlow—15; Lewelling—12; Oregon City—7; Salem— 9; and Spencer Butte—9. [The members' names can be viewed in the OAP History Scrapbook.]

Over the past several years all of these five organizing units have been dissolved. Yet, as we take note of the names of the units represented here today, we must not overlook the fact only one of the early units is still in existence. Although not a charter unit of OSAP, the Rose City Unit, organized in 1961, has stood like a rock in the ever-changing time and membership of the Oregon Association.

Amend Oregon Association of Parliamentarians bylaws by inserting the following between B. **Members-at-Large** and C. **Full-Time Students** in **Article III: Divisions/Members**, **Section 2. Members**, and renumbering subsequent paragraphs:

C. **Affiliate Members.** Affiliate Members shall be NAP members whose primary membership is in another association, but who choose to also be members of OAP. Such members shall have all the rights and privileges of membership in OAP.

Rationale: Currently OAP affiliate members are categorized as unit members, but really should be categorized independently.

Proposed amendment:

Amend Oregon Association of Parliamentarians bylaws by striking all occurrences of the word "chairman" and inserting "chair" in its place, and by striking all occurrences of the word "chairmen" and inserting "chairs" in its place.

Rationale: We suggest using the gender-neutral terms instead of the current terms.

Authorize Bylaws Revision

Proposed motion:

That the Bylaws/Procedure Manual committee be authorized to prepare a proposed revision to OAP bylaws for consideration at our 2022 annual meeting.
